Reauthorization Bill Passes Senate by Unanimous Consent

On Tuesday, June 6, 2000, the Senate passed the Ryan White CARE Act Amendments of 2000 (S. 2311) by <u>unanimous</u> consent. The bill's passage without any dissent or debate reflects both our collective and intense advocacy initiative over the past two years and the strong grassroots and Congressional support built during the past decade. FY 2001 Appropriations

Members of the Senate still need to hear from constituents regarding the FY 2001 appropriations. The Senate amounts for Title I and Title III of the CARE Act, which have passed the Appropriations Committee, are substantially below the numbers passed by the House Appropriations Committee and the President's request. Call or write your senators and urge them to support CARE Act funding levels that match the House budget.
