RESTRICTIONS ON MINORS' ACCESS TO ABORTION (cont.)

1. This statute has been declared unenforceable by a court or attorney general.

2. This statute also allows consent of or notice to a grandparent under certain circumstances.

3. This requirement may be waived by a specified health professional under certain circumstances.

4. This statute requires notice to a minor's parents, if possible.

5. This statute also allows consent of or notice to a grandparent or step-parent.

6. This statute also allows consent of an adult family member.

7. This statute requires mandatory counseling and allows a minor to obtain an abortion without parental consent if the physician secures informed written consent of the minor and the minor is mentally and physically competent to give consent.

8. This statute requires two-parent consent, but a court has issued an order that the law be enforced as requiring the consent of one parent.

9. This statute also allows notice to a grandparent, step-parent or adult sibling over the age of 21 under certain circumstances.

10. This statute allows consent of or notice to a grandparent or certain other adult family members over the age of 25.

11. This statute requires notice to both parents, but allows notice to one parent, if the minor requests, and if the parents do

not reside together.

12. In the case of a medical emergency, the physician may perform an abortion without parental consent but is required to attempt to notify a parent of the procedure and to obtain consent.
