
MIASF Celebrates 25th Anniversary Milestone of Waterway Cleanup

s the March 2nd date for the 25th Annual Waterway Cleanup approaches and the public relations and marketing plans are implemented, interest among volunteers and sponsors in the largest environmental event in Broward County is growing. Numerous local community and civic organizations, neighborhood groups, individuals, and businesses are pledging their time, resources and dollars to ensure its success as a community and environmental project.

A legislative update from Linda Cox of Skelding & Cox

Sales Tax Constitutional Amendment

fter the uproar surrounding the Senate's first attempt at drafting a constitutional amendment to revise the tax structure, the Finance and Taxation Committee offered a rewrite on January 25. Our understanding is that the Constitutional Amendment did not address the tax exemptions in the statute. The amendment stated that the amount of sales tax will be reduced to 4 1/2 percent and certain items, which traditionally have not been subject to the sales tax, will be stated as exempt. This includes such things as the sales of intangibles, sale for resale, imports for exportation. There will be another bill which will implement the constitutional amendment, which will list the items which will remain exempt from the sales tax - So far it looks like insurance premiums, advertising, in-house labor, trade-ins will be included. We are not sure what other items will be included. Everything else will be subject to tax unless the Legislature reinstates the tax exemption. Obviously we will be lobbying to make sure that our "10-90" exemption for boat sales to out-of-state buyers is on the list of those items which remain exempt.

Fuel Tax Generated at Marinas

When it rains it pours. As you know, Senator King and Rep. Dockery have filed our bill to require that fuel taxes raised at marinas be spent on onthe-water law enforcement and water point access. The bill was to be effective five years from now so that DOT couldn't claim that the fuel tax money was already committed to the five-year work program. Rep. Dockery wants to give us part of the money this year. Senator King has already sent a letter to Secretary Barry stating his intent to make the bill effective in five years and does not want to go back on his word.

Yacht Brokers

We have been in touch with Ross Fleetwood, the Director of the Division

that regulates yacht brokers. We explained that Peter Butler had gone to Annapolis and indicated that out of state yacht brokers could operate in Florida without a license based on a court case. The General Counsel and Fleetwood agree that the case was not precedential. Fleetwood has agreed to send out a press release stating that yacht brokers cannot operate in Florida without a license.

Lemon Law

Rep. Melvin has filed a vessel lemon law bill, but has indicated that the wrong bill was filed. It was supposed to be a dealer bill. No language is available at this time.

Harrington's Manatee Bill

The final workshop on the bill was held on Friday, January 25. Apparently, the FWCC is relatively happy with the bill, which means they don't like it but can live with it. Of course, the Save the Manatee Club is not happy. Indications from the Natural Resources Committee when it took testimony during committee meetings this month were a favorable response. The proposed legislation requires that any rule proposing to govern the speed and operation of motorboats for purposes of manatee protection be submitted to the county for review by a local rule review committee. The make-up of the committee will probably be massaged at the workshop. The bill also requires a review of existing rules on a timetable.

Existing language requires regulation only where manatee sightings are frequent and it can be generally assumed, based on available scientific information, that they inhabit these areas on a regular or continuous basis. The new language reads, "sightings are frequent and the best available science, including but not limited to manatee surveys, supports the conclusion that manatees inhabit these areas on a regular or continuous basis." We are attempting to change the word "supports" to "documents."

The bill also states that no later than February 15, 2003, the commission shall develop a measurable biological goal that defines manatee recovery. This manatee

New Marina Group Gaining Momentum

The new Marina Group received an enthusiastic response to their meeting on January 24 at the IGFA Fishing Hall of Fame. Nearly 50 members and guests assembled to hear Bill Yeargin of Rybovich Spencer give an inspirational talk on the Essentials of Leadership. Several members expressed regret for not sharing this educational opportunity with their employees.

After the presentation, the group discussed the challenges the marina industry faces and how the MIASF Marina Group can best serve them. Education and information about relevant topics appeared to be the answer to most issues and as a result the Marina Group has scheduled two upcoming seminars.

On February 27, there will be a seminar on "How To Comply with Tier II Reporting." As you may or may not know, legislation passed in 1986 requires all marinas dispensing fuel to complete Tier II reports annually, but the Environmental Protection Agency (EPA) did not begin enforcement of this regulation until 1994. Recently, inspections were conducted in South Carolina and five marinas faced stiff penalties for failing to submit their Tier II reports. This informative meeting will be held at 6:30 p.m. at the IGFA on February 27.

Also, on March 7 there will be a seminar on "Fire and Emergency Planning for Marinas" presented by Gene Spinazola P.E. Gene is a former instructor at Maine Maritime Academy and Interna-

2001 Saw More Manatee Deaths; About the Same Number Related to Boat Activity

Boat-related manatee deaths in Florida remained about the same last year, although manatee deaths in general were higher.

Of the 325 manatee deaths reported in Florida in 2001, 81 were the result of watercraft-related injuries, said officials with the Florida Fish and Wildlife Conservation Commission's Florida Marine Research Institute. In 2000, 273 deaths were reported and of those, 78 were attributed to watercraft.

IGFA Hall of Fame Gets 'Piece of History'

Zane Grey's Avalon Is On Display

hen you first glimpse the wooden boat sitting on a cradle in front of the IGFA Hall of Fame and Museum in Dania Beach, you might mistake it for a restored Cuban refugee vessel. The lapstrake design, low freeboard and mast on the shiny, white-painted "Avalon" are common features of fishing boats that freedom seekers often commandeer out of Havana Harbor.

The "Avalon" belonged to author/ fisherman/dentist/baseball player Zane Grey, and now it is on permanent display in South Florida. According to IGFA, Grey had the "Avalon" built at the New Zealand shipyard Collings & Bell to be used as a day-fishing boat towed around behind his 146-foot-live-aboard yacht, "The Fisherman."

Two New Slow Zones For Florida County

From Soundings Trade Only

Pederal officials say they will create two new speed zones in Florida's Brevard County to protect the endangered manatee. The new speed zones are part of a settlement reached by the U.S. Fish and Wildlife Service with a coalition of environmental organizations that had sued for increased protection of the sea cows.

Wildlife officials also have agreed to look into protecting an additional 14 highrisk areas around the state.

Association Calls for Creation of Dredging Commission

The Marina Operators Association of America called for the creation of the National Recreational Dredging Commission (NRDC) at a recent meeting of the Board of Directors.

Because marinas and recreational boating facilities depend on maintaining and restoring adequate water depths for their economic survival, MOAA believes the industry needs to create an entity charged with creating a coordinated environmentally compatible dredging policy and blueprint.

The politics of dredging currently consist of a combination of inexact science and misguided belief that dredging is a choice between recreation and the environment, or recreation and commerce, according to MOAA.

New dredging policy

The new dredging policy would include solutions to the relocation of dredged materials, as well as studying available science to ensure that dredging is handled in a cost-effective and environmentally friendly manner. In addition, the proposed commission would be asked to create federally subsidized, regional programs to handle dredged materials, prioritize federal recreational boating dredging projects, and secure the necessary funding for federal dredging and participation in local relocation areas, said MOAA.

Watson Island Led Lobbying

iami City Hall hosted 143 lobbyists in 2001, some with many more clients and more successful in their ventures than others, city records show.

By far the most lobbied project was the redevelopment of the city-owned Watson Island. Companies seeking to develop the parcel of land that sits between downtown Miami and Miami Beach hired 29 lobbyists to try to convince city commissioners to choose their proposal, according to a list of lobbyists published by the city.

In the end, commissioners chose Flagstone Properties's project, consisting of two hotels and a megayacht facility. "It was truly a team effort," said Paul Kissinger, one of a team of 17 lobbyists hired by Flagstone. "It was a very fair process. We followed all the rules with regard to the presentation. We were selected not because of the lobbying effort but because we had the best project for the city."

City leaders say lobbyists in Miami are not nearly as pervasive as in Miami-Dade County. Miami Commissioner Johnny Winton said lobbyists, who must pay a \$500 annual fee to lobby the city, seldom visit him to push their agendas. "It is a night and day difference between the City of Miami and Miami-Dade County," Winton said.

Intracoastal Waterway Can Provide Big-time Fishing Action

The first thing you notice when fishing in the Intracoastal Waterway is the lack of other anglers. The second thing you notice is the abundance of fish.

A recent morning trip produced barracudas, mangrove snappers, jacks, ladyfish, blue runners and snook by plugcasting, trolling and live-baiting around docks, seawalls, channel edges and shorelines in Deerfield Beach and Boca Raton. The only other fishermen were an osprey and blue heron and neither of them enjoyed the same success.

MIASF and City of Miami Meet, Set the Stage for Industry and Government Teamwork

embers of the MIASF met with City of Miami Commissioner Johnny Winton and several staff members involved in the City's waterfront—related issues on February 4 at City Hall to formally introduce the MIASF and discuss some areas of common interest with the City.

On the agenda was the new Flagstone mixed-use development slated for Watson Island on Biscayne Bay. The City is in lease agreement negotiations with the developer and is very interested in having input from the local marine industry as it pertains to the development's proposed 48-slip megayacht marina

Cathy Johnston of the NMMA took time away from Miami International Boat Show preparations to attend the meeting and was encouraged by Commissioner Winton's suggestion to look into the possibility of additional dockage for the Show at Bi-centennial Park, in the future.

A major redevelopment plan for

Bicentennial Park is in the early planning and funding stages, and includes plans for megayacht dockage. MIASF Executive Director Frank Herhold explained that megayacht dockage would have significant economic impact on the City and cited how the City of Fort Lauderdale has benefited from megayacht visits.

Ed Swakon of EAS Engineering provided information regarding the Biscayne Bay Initiative, which could be a source of funding for a new marine industry economic impact survey for Miami-Dade. Ed commented on another related study by Florida Inland Navigation District (FIND), which will assess the economic impact of dredging the Intracoastal Waterway. All agreed that it is important to quantify the economic contributions of the marine industry in Miami-Dade.

Commissioner Winton expressed particular interest in seeking our assistance in locating marine businesses that may have an interest in participating in waterfront redevelopment projects.

Commissioner Winton was invited to attend the Miami-Dade MIASF member business breakfast meeting on February 15 at Double Tree Grand Hotel, in the hotel's Grand Room, 1717 North Bayshore Drive, Miami, FL. NMMA President, Thom Dammrich will be the featured speaker. He provide members with a preview of the Miami International Boat Show and present recent performance trends in boat shows and boat sales around the country. All MIASF members are invited to attend the meeting. Reservations are required. Call the MIASF office at 954-524-2733.

Winterfest Boat Parade Injects \$24 Million into the South Florida Economy

The fireworks have ended and the beautiful boats are no longer adorned with holiday and patriotic decorations, but the memories and impact of the Cingular Wireless Winterfest Boat Parade sponsored by Nokia remain unquestionable.



volunteers cleaning up the waterway. Kopet said, "For the 25th anniversary I wanted to show the underwater life as well

as some volunteers at work and the Florida waterways. I think those images really represent everyone involved in this tremendous environmental project."

Each year, several hundred volunteers with boats go to cleanup sites and remove debris from the water while thousands more on land clean up the shoreline areas and help unload the trash brought in by the boats. There are many dedicated people

who return each year to help with the cleanup, however this year one person will celebrate his 25th anniversary as a Waterway Cleanup volunteer. Richard Rothe is a veteran site coordinator at Wilton Manors who has seen the Waterway Cleanup grow from a project of only a small number cleanup sites in 1977 with only a few hundred volunteers, to 31 cleanup sites in 2002 with more than 3,000 volunteers. "I've lived in Fort Lauderdale since 1957, I'm a Department Head in Wilton Manor's Park and Recreation Department and the Waterway Cleanup is how I repay our waterways. Boating is a part of my life and I've always enjoyed the water. MIASF takes the lead in this project and the

Longshore News...

Members Showing Strong Interest Longshore Issue

The MIASF Longshore Committee began 2002 continuing an active schedule of meetings and teleconferences aimed at removing the recreational marine industry from the Longshore and Harbor Workers' Compensation Act (LHWCA). With their three-phase plan-of-action of strategy, awareness and education fully in focus, the committee continued their pursuit for legislative change.

A meeting with U.S. Representative Ric Keller was held in District (Orlando), with the focus of achieving lead sponsorship of a bill amending the LHWCA. The MIASF delegation included Longshore Committee Chair Kristina Hebert, Executive Director Frank Herhold, and member Walter Meloon. Mr. Meloon is president of Correct Craft, a manufacturer of

inboard ski boats and family runabouts for over 75 years, and also a constituent of Rep. Keller. The

Florida Marine Contractors Association Past President, Rick Fender was also present as well as the National Marine Manufacturers Association (NMMA) Governmental Affairs Director, Kelly Bobek and the Marina Operators Association of America (MOAA) Legislative Director Stacey Proctor.

Upon review of the adverse affects and a reiteration of the need for change, Rep. Keller not only agreed to be the lead sponsor of a bill with language excluding the entire recreational marine industry from the jurisdiction of LHWCA, but also requested quantifiable data that would reflect the positive effects on the industry if removed from the Act. The MIASF,

FMCA, NMMA and MOAA have all agreed to poll their membership and gather information that will produce these statistics. Initial reports show that 60% of MIASF members who have submitted their survey would expand their business if Longshore coverage was no longer required AND of those, 80% said they would hire more employees.

"The Impact of Longshore on your Business" was the title of MIASF's January Business Breakfast, held at the IGFA Fishing Hall of Fame. This was the largest Business Breakfast meeting ever held with nearly 120 members and marine industry interests in attendance. Members were extremely interested in the report on recent legislative developments given by Kristina Hebert. While lauding the efforts

> the committee and re-affirming their support for changes in the current (LHWCA),

Kristina reiterated the challenges our industry faces each day with the Act's complex regulation and draconian effects.

At the upcoming Miami International Boat Show, the MIASF has scheduled a Longshore meeting to serve as a forum for organizations and marine industry businesses that have concerns about the effects of the Longshore and Harbor Workers Act. The agenda will include the development of a renewed legislative strategy, preparation for the upcoming NMMA Marine Legislative Conference and finally the formation of a national coalition. It is imperative that all facets of our industry unite. For this proposed bill to pass, the recreational marine industry

must achieve co-sponsorship from legislators across the country. MIASF is fortunate to have a strong relationship with U.S. Representative Clay Shaw who is a long-time supporter of the marine industry has already pledged his support for legislative change. Rep. Shaw is also Chairman of the Congressional Boating Caucus.

the right to fly the Clean Marina flag are MIASF members Harbour Towne Marina in Dania Beach, who also achieved the "Clean Boatyard designation, and Waterways Marina in Aventura.

Harbour Towne Marina is a 33-acre marine facility that encompasses a full

service marina, a full service boatyard, a variety of boat brokerages and a range of other unique attractions. At a recent award ceremony at the facility, DEP's Southeast District Clean Marina Coordinator, Cheryl Mckee said, "Harbour Towne Marina is the

first marine facility in Southeast
Florida to earn both the Clean
Marina and the Clean Boatyard
designations simultaneously." She
added, "These designations recognize Harbour Towne's commitment to
protecting and preserving

Florida's aquatic ecosystems."

Waterways Marina, a 99slip facility capable of docking vessels from 28 to 120 feet, was once a borrow pit and is unusual with its 40-foot depth and aeration system that

bubbles oxygen throughout the marina. During the awards ceremony for Waterways Marina it's harbormaster, Rob Helper said the marina was already fulfilling many of the Clean Marina requirements, however he added, "This was a way of getting recognition for the things we're already doing right."

The "Clean Marina" and the "Clean Boatyard" Programs were developed through a public/private partnership that includes the DEP, MIASF, Florida Sea Grant and the U.S. Coast Guard. In order to receive the designation marinas and boatyards must comply with all environmental regulations and meet criteria aimed at protecting the environment.

avid Clark was honored by the MIASF Board for being the oldest person to sail around the world solo. David covered 31,000 miles, visited 20 countries and, at one point, did not see land for 63 days. He expressed deep appreciation to the MIASF Board for their invaluable support and friendship during this venture.

Fort Lauderdale was showcased internationally as the "Boating Capital of the World" as CNN and six other major networks covered Mr. Clark's return to Fort Lauderdale, where he had departed over two years ago. It is estimated that in advertising dollars this exposure resulted in \$7 million worth of coverage.

The Marine Master Plan Steering Committee, chaired by Susan Engle, will review the Marine Summit Draft Report, revise where necessary and proceed to the implementation stage of the Master Plan.

The MIASF Workforce Committee, chaired by Scott Miser, will be sending a Workforce Survey to the membership in the near future to ascertain employment needs.

Martha Lord, Director of Association Services, presented the 2002 MIASF Association calendar for the Board. She also asked the Board to review a proposal for an online Job Bank to benefit members.
