


- 1982-2004









# Initial Conceptual Map






# Keywords

    - The abbreviations were not sufficient in narrowing the searches because they yielded stock quotes and ads, and the other keywords did not relate to the specific topic of drunk driving



- Drunk Driving and Driving While Intoxicated- .826





### Federal Government Attention to Drunk Driving


- 1982- Congress Designates the first National Drunk and Drugged Driving Awareness Week (*which would be designated each year until 1989*)
- 1982- Congress Amends title 23, US Code, to encourage the establishment by states of effective alcohol traffic safety programs
- 1984- Congress Designates the month of June as Student Awareness of Drunk Driving Month




## Federal Government Action on Drunk Driving

- 1982 Presidential Commission on Drunk Driving (*Renewed in 1983*)
  - Alcohol Countermeasures Incentive Grant Program created by Congress (Section 408)
- 1984 National Minimum Drinking Age established by Congress through an amendment of the Surface Transportation Assistance Act of 1982, increase the authorization of funds for highway safety programs (including minimum drinking age)
- 1988 Drunk Driving Prevention Incentive Grant Program
  - Created by Congress (Section 410)
  - All States enact Minimum Drinking Age


1990 - Congress Prevents the discharge in a Chapter 13 bankruptcy proceeding of certain debts arising out of the debtor's operation of a motor vehicle while legally intoxicated







# Statistical Data


- The percent of alcohol-related fatalities has declined from 60 percent in 1982 to 39 percent in 2005.
- Therefore, while non-alcoholrelated fatalities have increased the percent of alcohol-related fatalities have declined.


- The total vehicle miles traveled (VMT) increase 79% between 1982–2002
- Yet, the number of alcohol-related fatalities per vehicle miles traveled decreased 63%


